Medieval European History:

**Course Description:** In this 2<sup>nd</sup> year Undergraduate Course, the chronological framework for the course is the period in European History from the fall of the Roman Empire to the Renaissance in the 15<sup>th</sup> century. The subjects covered are the Age of Invasions, the Rise of Latin Christianity, the Carolingian Empire, Kingdoms and Lordships in Europe, Feudalism as a Historiographical Debate, the Rise of Trade, the Crusades, the Reconquista, the 12<sup>th</sup>–century Renaissance, Medieval Universities, the Black Death and Witchcraft.

Early Modern European History:

**Course Description:** This course is designed for 3<sup>rd</sup> year History students. It thematically surveys the important events that occurred in Early Modern Europe, through an analysis of the political, economical, social and intellectual trends of the period. Accordingly the chronological framework is between the 1500s and the 1800s and the subjects covered are the Renaissance, the Reformations, the Scientific Revolution, the Enlightenment, the Industrial Revolution and the French Revolution.

Modern European History:

**Course Description:** This course is designed for 3<sup>rd</sup> year History students. It starts off with the 1800s and is a survey course including discussions of important cornerstones of European History. These are covered by means of an analysis of the political, economic,

social and intellectual trends that occurred up to the 20<sup>th</sup> century. The subjects covered are the Rise of Nationalism in Europe and the Balkans, the Rise and Fall of Liberal Ideas in Europe, the First World War, the Rise of Dictatorships, the Great Depression, the Second World War, the Rise of the Idea of European Integration and the fall of the Eastern Block.

Research Methods in History:

**Course Description:** This is a 3<sup>rd</sup> year undergraduate course. The aim of the course is to provide tools and techniques for students of History so that they may understand and personally adopt methods of Historical Research. Accordingly, the areas that are covered in this course are the surveying of and analysis of historical literature, the process of choosing topics of research, writing techniques, presentation techniques, problems of interpretation, questions of objectivity and schools of thought in historical research.

History of Civilizations:

**Course Description:** This course is designed for 1<sup>st</sup> year undergraduates outside the History Department. It provides an analysis of the concept of 'civilization' and offers certain geographically diverse examples such as Chinese civilization, South American Civilizations, African and European Civilizations.

History of Political Thought:

**Course Description:** This course is designed for 3<sup>rd</sup> year undergraduate students. This course is a historical survey of canonical texts dealing with fundamental concepts in Political Thought. It includes a study of the historical developments of concepts such as sovereignty, liberty, equality, rights, and toleration, through a reading of thinkers starting with the Early Modern period and continuing to the 20<sup>th</sup> century. All the readings are primary sources and some of the texts chosen are from More, Machiavelli, Hobbes, Rousseau, Burke, Paine, Mill, Marx, Arendt and Hayek.

Reading Primary Sources in History:

**Course Description:** This course is designed for doctoral students as an elective seminar and it aims at deciphering Historical Material that is either in English or in German. Doctoral students choose the historical materials that relate to their prospective PhD projects and discuss these sources in conjunction with an analysis of the historiography on their subjects.

Intellectual History and Historiography: Philosophy

**Course Description:** This graduate course aims at providing a survey of texts and debates of Early Modern Philosophy. These texts will be discussed in accordance with the historiography of the subject materials in hand. One of the main issues we shall tackle here in this course is to find out about the place of Philosophy during the formation of disciplines, i.e. Humanities and Sciences. The relationship between philosophy and religion in Early Modern Europe, Materialism and its effects, the emergence of Secular Ethics will be some of the subjects that will be covered in this course.

Intellectual History and Historiography: Science

**Course Description:** The aim of this graduate course is to survey main trends in History of Science. The areas that will be covered shall be Aristotelian conception of universe, Renaissance Science, Humanism and Science, Copernican Revolution, Natural Philosophy and Scientific Revolution, The Mathematization of Universe, Darwinianism versus Religion in the 19<sup>th</sup> century. These subjects will be discussed in accordance with the traditions of history writing dealing with History of Science within the political, social and economic contexts.

## **H. RESEARCH INTERESTS**

### **Enlightenment/Counter-Enlightenment Debates:**

Eighteenth-century intellectual history, especially the Enlightenment/Counter-Enlightenment debates, has long been of major interest to me and an examination of them formed one of the main themes of my doctoral dissertation. My research and publications in this respect have contributed to the discussion of the role of orthodoxy within eighteenth-century thought, with a particular emphasis on the ways in which orthodoxy adapted itself and reacted to the high tide of progressive Enlightenment attitudes. The period I cover concerning this is c. 1660-1800.

### **Early Modern History of Science:**

I am interested in the relationship between science and religion, especially the emergence of anti-Newtonian cosmologies as a reaction to the potentially heterodox side of the New Science in the early eighteenth century. Accordingly I took up a research on the associated belief in divine analogy by the men of science and theology alike. I am currently working on Dutch Physician Herman Boerhaave (1668-1738) who was the most important mentor of Scottish medical students in the early eighteenth century. What is less known is that Boerhaave also had some influence on the discussions over natural philosophy concerning the credibility or otherwise of Newtonian physics. My recent work on Boerhaave is primarily concerned with how he played a role in the discussions of non-Newtonian fluid theory in the early eighteenth century, and as to where he stood between the mechanistic and vitalist camps.

**The Scottish Enlightenment and Science:** I am currently interested in Eighteenth-Century Scottish attitudes to Natural Philosophy. This interest has its origins in the research I have done on Forbes in Edinburgh, but has grown beyond its initial context and is now concerned with a wider reassessment of the century's intellectual history. The reception of Newtonian science in Scottish Presbyterian intellectual circles is an essential part my current research. From this study emerges an important point: debates that are essentially debates within the Kirk need to be recognized as an important feature of early Enlightenment debates in Scotland, but a straightforward association between Whiggery, the Moderates and the Enlightenment becomes questionable.

**Enlightenment Sociabilities:** The institutions of Enlightenment, universities, societies and clubs being among them, are obvious places to look for sociability. I consider societies and clubs in general as providing certain challenges to more formal spaces that offered intellectual activity, such as universities. I am currently working on a case study, which concentrates on *The Fair Intellectual Club*, which was founded in 1717 in Edinburgh by women. Not only does a study of this Club offer the possibility of yet another vehicle for Enlightenment ideas, but also it might prompt a rethinking of the Enlightenment as a masculine enterprise. That study of this club has been neglected could be symptomatic of certain blind spots in current scholarship, which necessitates a reassessment of the theories of Public Sphere that are associated with Habermas.
